Submissions must include the following:

- i) Presentation Title (10-word limit)
- ii) Presentation Abstract (50–75-word limit) – A brief description of the presentation learning outcomes
- iii) Presentation Plan (50-word limit) – A brief description that provides an overview of presentation methodology and expected audience involvement. Interactive presentations are highly encouraged.
- iv) Presentation Summary (250–300-word limit) – Extended description of proposal for committee review. Proposals will be reviewed for relevance to conference themes, thoroughness, clarity and expected learning outcomes. KEBS-NQI reserves the right to edit summaries of accepted presentations for inclusion in the conference communication fliers, banners, and / or program.
- v) More than one proposal may be submitted, but only one will be accepted per presenter.
